Membership fee	Not all countries paid their MF for 2015. Reminders were sent. We are looking for a suitable solution.
Bank costs	We decided to pay the travel grant by bank for safety and security, however the bank costs therefore increased.
Travel grant 24hrs	There were at a very late moment, troubles at Turin. Just 2 weeks before the race we heard that the LOC had been dismantled with a complete financial loss. To make the WC happen IAU worked with FIDAL and IUTRA with FIDAL taking on accommodation expenditure and the IAU Council I decided to use a part of the IAAF grant for paying the TG to the participants Otherwise the WC should have been cancelled 14 days before the date. For the council this was no option.
Travel grant Trail	An extra amount was paid by the IAU. Reason was that more countries with qualified runners took part than expected. Before the invitations goes out a calculation of the Travel grant is made based on experience in previous years. We did not want to change the amount for each country after sending out the Travel grant letters.
Travel grant 100 k	A small amount was paid by the IAU. Reason was that more countries with qualified runners take part. (see above) Before the invitations go out a calculation of the Travel grant is made based on experience in previous years. We did not want to change the amount for each country after sending out the Travel grant letters.
Travel grant 50 k	Here we see that the money spent for Travel grant was less then the amount paid to the IAU by the LOC. More runners/teams were expected than participated. It is a race which should grow in the coming years.
Bid Deposits	This is not really income, because the LOC will get it back after the selection procedure.
